Mr. Guzzetta is a recognized expert in privacy law, and has almost 15 years of experience counseling clients in complying with U.S. privacy laws, including the California Consumer Privacy Act (CCPA), the Children’s Online Privacy Protection Act (COPPA), the Health Insurance Portability and Accountability Act (HIPAA), the Telephone Consumer Protection Act (TCPA), California’s data broker registration law, and the Gramm-Leach-Bliley Act. He also has extensive experience counseling clients in complying with various foreign privacy and data security laws and regulations, including the European Union’s General Data Protection Regulation (GDPR), the Chinese Personal Information Protection Law (PIPL), Canada’s Personal Information Protection and Electronic Documents Act (PIPEDA) and Quebec’s Law 25.

He regularly drafts privacy policies, data processing agreements, and privacy-related disclosures, counsels clients on the privacy-related aspects of financings and change of control transactions, and responds to data security incidents.
